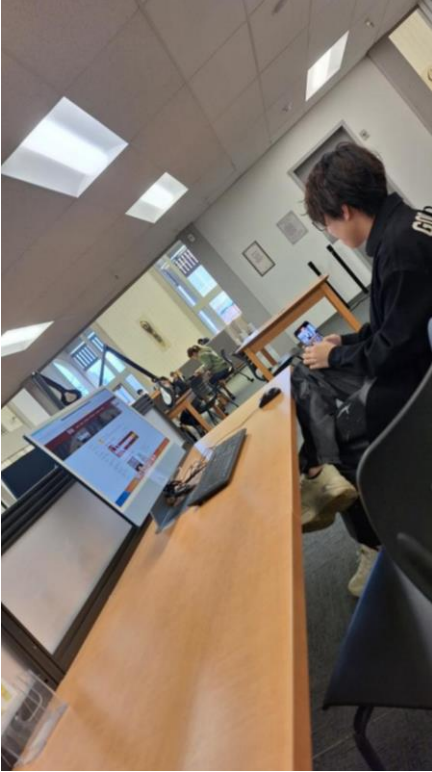

The story erupted between 2:00 and 2:40 PM on March 5, while I was campaigning in the library. Suddenly, my friend sent me a message, informing me of an urgent matter. In my haste, I found my friend, and at that time, another acquaintance of my friend, whom I hadn't met before but who recognized me from my campaigning, revealed something that left me horrified and trembling with anger: a male had been secretly filming video of me from a distance, with a strange smile on his face, but pretended to look at his computer when I turned around. It seemed he was unaware that his actions had been noticed, and his photo, taken while he was secretly filming, was captured by my friend's acquaintance, suspecting illegal or creepy stalking behavior. The moment I saw the photo, I was utterly shocked and enraged because the individual was a close friend of my competitor, Phoebe. Considering these factors, I seriously suspect this was a highly malicious competitive incident, and I reasonably suspect they had ulterior motives with my video and that was an invasion of my privacy. Last Thursday, I learned from a mutual friend of Phoebe and me that she claimed to have heard from many people that I had spoken ill of her, but the truth is I never said anything bad about her. I have been focusing on my own campaign and answering different students' questions every day, with no time to speak ill of my opponents. In fact, I have always stated that my competitors are strong and competitive. However, Phoebe began to show unfriendly intentions towards me a week before the campaigning and told our

mutual friend that I appeared unfriendly. This time, she firmly accused me of speaking ill of her in front of our mutual friends, without providing any evidence. Up to this point, I simply thought she was too eager to win, which I could understand since I also wished to win. Considering our past friendship, I didn't want to make a big deal out of it and was waiting for the election committee's judgment, believing in my own innocence. However, today's incident has made me feel an unprecedented level of unease because the man's behavior was truly unsettling, and even from the photo it was evident he was snickering while secretly filming. I believe any women seeing this would instinctively feel physically uncomfortable and understand my feelings. What's worse, I have been a victim of sexual assault in the past, and such secret filming has caused me significant psychological stress, leading to severe depression, and recently, I received a letter from the school's Title IX office informing me that I needed to attend a hearing, which is undoubtedly a double psychological blow to me and has greatly affected my life. Given the relationship between Phoebe and this man, I find it is hard not to suspect this was a deliberate and aware act because I had seen that man once, and Phoebe affectionately called him her brother, and many people saw them sticking together while campaigning. Considering these factors, I seriously question their purpose in secretly filming me, as I have been a victim of campus bullying, and I know what such secret filming implies. They would definitely spread and personally humiliate me within their small group, and by this evening, I gradually heard from several people that they heard Phoebe's side spreading information about me. I believe this has escalated to collective bullying behavior, and therefore, I think I can no longer sit by and allow this situation to continue fermenting. If it were not for being witnessed by bystanders, I would never know I was being monitored by someone else's camera. When you spot a cockroach in the sunlight, it means the shadows are already too crowded, and such a low-probability event of being secretly filmed has already been witnessed by onlookers, I do not know how many times it has happened without my knowledge, and I believe my personal safety is now threatened. Before writing down what I have experienced, I went through a great deal of psychological struggle because I know compared to my competitor, the other side seems to have more people familiar within DASG, and I believe it is hard for everyone to believe such a malicious event could happen. Before being informed by the witness, I also dared not believe such a terrible event could happen. I cannot imagine my former friend allowing those experiences that forced me to rely on a therapist to live to be repeated, and I cannot imagine that the campus, which I once trusted, loved, and healed in through friendship, would experience such an event. With the support of my family, I sincerely write these words, hoping that the relevant departments will thoroughly

investigate such a malicious event. I hope and believe that the relevant departments can make a fair judgment.
